OHHF'S COMMUNITY OUTREACH PROGRAM PROVIDES INDIVIDUALIZED SUPPORT TO EASE THE HARDSHIPS EXPERIENCED BY HEART FAMILIES. THIS IS ACHIEVED THROUGH FINANCIAL GRANTS AND CARE PACKAGES; CONNECTING HEART FAMILIES THROUGH EVENTS; BUILDING BONDS FOR LIFELONG SUPPORT; AND CREATING A NETWORK THROUGH PARTNERSHIPS. IN 2023, OHHF SPENT \$70,365 ON FINANCIAL ASSISTANCE GRANTS AND CARE PACKAGES. HEART FAMILY EVENTS CONTINUED WITH MEALS TO A LOCAL HOSPITAL HEART CENTER, TOPGOLF HEART FAMILY EVENT, HEART FAMILY MOVIE NIGHT, AND THE ANNUAL HEART MOM ORNAMENT EXCHANGE.

OHHF'S OLLIES' BRANCH PROGRAM OFFERS COMPASSIONATE, ACCESSIBLE MENTAL HEALTH SUPPORT TO ALLOW PEACE OF MIND FOR FAMILIES AND CAREGIVERS OF CHILDREN WITH OR AFFECTED BY PEDIATRIC HEART DISEASE. HEART FAMILIES (INCLUDING HEART WARRIORS, PARENTS, GRANDPARENTS, SIBLINGS, OTHER CAREGIVERS, AND EVEN THE HEALTHCARE PROVIDERS) CAN ACCESS A DIVERSE COMMUNITY OF THERAPISTS THAT SPECIALIZE IN THE TRAUMA HEART FAMILIES FACE AND SUPPORT THROUGH THERAPY SESSIONS OFFERED AT NO COST TO THE RECIPIENT. IN 2023, OHHF'S COMMUNITY GREW TO 253 LICENSED THERAPISTS THAT PROVIDED 3,808 THERAPY SESSIONS FUNDED BY OHHF. ALSO IN 2023, OHHF CONTINUED FUNDING A PRIOR-YEAR COMMITMENT FOR A FULL-TIME AND A PART-TIME THERAPIST ON-STAFF AT A LOCAL HOSPITAL.

OHHF'S TECHNOLOGY AND RESEARCH PROGRAM STRIVES TO IMPROVE OUTCOMES IN PEDIATRIC HEART CARE BY COLLABORATING WITH INNOVATORS ON CUTTING EDGE ADVANCEMENTS. IN THE SUMMER OF 2023, OHHF LAUNCHED A CUSTOMIZABLE TELEHEALTH SOLUTION IN PARTNERSHIP WITH LOCUS HEALTH, ENABLING OLLIE'S BRANCH THERAPISTS AND CLIENTS TO CONNECT VIA A SECURE APP FOR THERAPY SESSIONS CONVENIENTLY ON THEIR DESKTOP OR MOBILE DEVICE, OR A DEVICE PROVIDED TO THEM BY LOCUS HEALTH. THIS HAS ALLOWED OHHF TO SUPPORT AN UNDERSERVED, VULNERABLE COMMUNITY THAT MAY LACK ACCESS TO TECHNOLOGY, WI-FI, AND CELLULAR TO CONNECT WITH OHHF'S THERAPIST COMMUNITY TO RECEIVE TIMELY AND INDIVIDUALIZED MENTAL HEALTH SERVICES.
