

## **NEIGHBORHOOD ASSISTANCE** PROGRAM TAX CREDITS

Minimum Gifts of \$5,000 or more to Ollie Hinkle Heart Foundation (OHHF) may be eligible to receive Neighborhood Assistance Program Tax Credits through the state of Missouri. These tax credits can be used to reduce Missouri tax liability for either Missouri businesses or individuals with Missouri business income. OHHF is able to offer these credits at a rate of 50% of your total donation to OHHF's Missouri Community Outreach and Ollie's Branch programs.

## **HOW IT WORKS**

YOUR \$50,000 GIFT TO OHHE

LOWER TAXES BY \$25,000 (NAP CREDIT)

AND

COMBINED TAX SAVINGS OF \$10.500 (TAX DEDUCTION)\*

**ACTUAL EXPENSE** \$14,500 **OUT OF POCKET\*** 

YOUR \$15,000 GIFT TO OHHF

LOWER TAXES BY \$7.500 (NAP CREDIT)

AND

COMBINED TAX SAVINGS OF \$3,000 (TAX DEDUCTION)\*

**ACTUAL EXPENSE** \$4,500 **OUT OF POCKET\*** 

YOUR \$5,000 GIFT TO OHHE

LOWER TAXES BY \$2,500 (NAP CREDIT)

AND

COMBINED TAX SAVINGS OF \$1,000 (TAX DEDUCTION)\*

**ACTUAL EXPENSE** \$1,500 **OUT OF POCKET\***

## STEP 1: Determine Eligibility

The following contributors are approved to receive Neighborhood Assistance Program (NAP) Tax Credits:

STEP 2: Make a Minimum Contribution of \$5,000 to OHHF to Claim Your Neighborhood Assistance Program (NAP) Tax Credits

STEP 3: Receive and Complete Your Neighborhood Assistance Program (NAP) Tax Credit Application

Once your gift has been received, OHHF will send you a Neighborhood Assistance Program Tax Credit application. You will be required to fill out the application, provide proof of donation and have the application notarized.

## STEP 4: Return the Completed Application to OHHF

After returning your completed application to OHHF, we will sign off on the application and send it to the Missouri Department of Economic Development (DED) in Jefferson City for processing. Applications must be received by DED within one year of the date of donation. It typically takes 4-6 weeks for applications to be processed at which time you will receive a letter from the DED which includes the information you need to claim your tax credits. Donors have the tax year the contribution was made plus the five succeeding tax years to claim the credit on their tax return.
